

Notice Inviting Quotation

For

Purchase of Consumable items/tools and PPE for Advance Electrical Lab

1. Sealed quotations are invited on or before **27 May 2025 up to 05:00PM** from the reputed firms/organizations/dealer/supplier for the purchase of consumable items/tools and PPE for Advance Electrical Lab after approval of competent authority vide E-file (**SVSU-AARS/35/2024-SFET**). The technical bid and financial bid sheet is attached at Annexure-I and Annexure-II
2. Interested firms are requested to quote minimum price along with complete terms and conditions regarding validity of rates, delivery period, item as per specifications, taxes etc. Conditional/Partial quotation will not be accepted.
3. The sealed quotations, complete in all respect, must reach by post/by hand in the office of **“Skill Department of Green Technology under Skill Faculty of Engineering and Technology(SFET), Room No.09, Lalitgiri Bhawan (Block 1E), Shri Vishwakarma Skill University, Village- Dudhola Palwal, Haryana-121102 latest by 27 May 2025 up to 5:00PM.**
4. The Quotation shall be submitted in double envelope.
Envelop-I:- Should contain Technical bid documents.
Envelop-II:- Should contain Financial bid documents.
The inner envelope shall be sealed and shall have the superscription **“Consumable items/tools and PPE for Advance Electrical Lab.** The offer may be sent to the **Skill Department of Green Technology under Skill Faculty of Engineering and Technology(SFET), Room No.09, Lalitgiri Bhawan (Block 1E), Shri Vishwakarma Skill University, Village- Dudhola Palwal, Haryana-121102.**
5. Quotations invited for “Consumable items/tools and PPE for Advance Electrical Lab” must be clearly written on the sealed envelope. The quotation received after due date and time or incomplete shall be out rightly rejected.
6. TDS and GST as amended from time to time by the Government will be deducted by the university from every bill of the agency.
7. Charges not mentioned in the quotation shall not be paid.
8. The firm must have GST number printed on their quotation. The quotations without GST number shall be out rightly rejected.
9. Evaluation Method: The evaluation method will be on Total value evaluation, not on the basis of item wise.

10. FOR shall be Shri Vishwakarma Skill University, Dudhola, Palwal, Haryana.
11. Rates should be quoted for FOR destination.
12. The quotation offer must be valid for a period of at least 90 days from the date of submission of quotation.
13. The quantity may increase or decrease without any notice.
14. No advance payment against documents negotiated through the bank shall be made.
15. Terms and Conditions printed on the Quotation of firm, if any, shall not be binding on the university, except those mentioned specifically on the supply order, and your acceptance of the order shall be constructed as your agreement to all term and conditions contained in the order.
16. SVSU reserves the right to accept or reject any or all the bids received without assigning any reason.
17. In case of dispute or difference arising between the purchaser and supplier related to any matter connected with inviting quotation document such disputes shall be settled in accordance with the Indian Arbitration & Conciliation Act, 1996, the rules there under and any statutory modifications or re-enactments thereof shall apply to the arbitration proceeding. Arbitrator will be decided with the mutual consent of both the parties. The award of the arbitrator so appointed shall be final, conclusive and binding on all parties to this order.
18. The contract shall be interpreted in accordance with the laws of the Union of India. The place of jurisdiction would be Palwal, Haryana.
